## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Snoqualmie Valley Hospital from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Restricted funds – revolving line of credit/bridge loan
- Third-party cash receipting
- Payroll – overtime disbursements

### **Financial**

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Snoqualmie Valley Hospital.

## INFORMATION ABOUT THE DISTRICT

King County Public Hospital District No. 4, doing business as Snoqualmie Valley Hospital, operates a hospital and network of clinics serving Fall City, North Bend, Carnation, Preston, Snoqualmie, Snoqualmie Pass, and parts of unincorporated east King County.

An elected, five-member Board of Commissioners governs the District. Commissioners serve staggered, six-year terms. A Board-appointed Chief Executive Officer oversees the District's daily operations, as well as its approximately 210 employees. For fiscal year 2014, the District had operating revenue of \$24.8 million.
