Policy : Death with Dignity Act

Summary/Intent

To recognize the Washington State "Death with Dignity Act," herein referred to as the "Act" (RCW 70.245/WAC 246-978)

Policy: Compliance - Key Elements

SVH will allow its health care providers to participate in the process set forth in the Act if they so choose and respects the right of any health care provider to decline to participate in activities specific to the Act, subject to the provisions of this and any other applicable hospital policies. SVH will comply with House Bill 1608 – Providing Information to Patients by providing a copy of the information regarding this law at the time of hire, contracting, privileging and yearly thereafter to health care providers and staff.

PUBLIC NOTICE:

SVH will provide public notice of this policy in the following ways: posting the policy or information about the hospital's stance on the Death with Dignity Act on the hospital's web page; including in hospital materials regarding advanced directives.

SVH will comply with The Assisted Suicide Funding Restriction Act of 1997 (P.L. 105-12) which prohibits the use of Federal funds to provide or pay for any health care item or service, or health benefit coverage, for the purpose of causing, or assisting to cause, the death of any individual including mercy killing, euthanasia, or assisted suicide.

PROCEDURE:

Qualified health care providers (defined as a person licensed, certified, or otherwise authorized or permitted by law to administer heath care or dispense medication in the ordinary course of business or practice of a profession, and includes a healthcare facility) who are willing to participate, are employed and properly credentialed by SVH may, as otherwise allowed:

- · Perform the duties of an attending provider;
- · Perform the duties of a consulting provider;
- · Prescribe a life-ending dose of medication;
- · Provide counseling in connection with the provision of a life-ending dose of medication; and/or
- Perform other duties as provided for in the Act.

Health Care providers who decline to participate may:

· Refer the patient to other resources that can provide such support

• If any SVH provider participates in the "Washington State Death with Dignity Act" with a patient of this hospital, that provider must immediately notify the Chief Medical Officer. It is the provider's responsibility to ensure the correct procedures are followed and the correct documentation is completed in accordance with the Act and hospital policy.

· Hospital administration may provide oversight and may review records to the extent necessary to ensure all the safeguards of the law have been followed and the required documentation completed and submitted to the Department of Health.

DISPENSING AND INGESTING OF A LETHAL DOSE OF MEDICATION: The SVH position is that its acute care hospital and its clinics are not the appropriate setting for patients who are at the stage of taking life-ending medications.

In accordance with this policy, the final actions ending a patient's life, under the specifications of this Death with Dignity Act, shall not occur on or within the premises of the hospital or in clinics operated by the District. The patient's self-administration of the lethal medication is not permitted on the District's premises. Also, the medication for this purpose will not be dispensed from the hospital pharmacy.

*Pursuant to the DWD Act, RCW 70.245.190, individual providers and facilities may choose whether or not to participate in the DWD			
Act. "Participate" means to perform the duties of the attending gualified medical provider, the consulting gualified medical provider,			
or the counseling function under the DWD Act.			
Allows providers to participate in the Death with Dignity Act at the hospital*			
Regardless of whether or not a hospital participates in the DWD Act, the hospital supports providers to:			
 Certify that a patient has a terminal disease and provide the patient information about the medical prognosis pursuant to documentation required under the DWD Act. 			
 Give information about the DWD Act to a patient upon request, including information about what relevant resources are available and how to access them. 			
 Document a patient's first written request for medication that the patient may self-administer to end their life in a 			
humane and dignified manner in the patient's medical record per the DWD Act			
 Refer or transfer care of a patient to another attending or consulting gualified medical provider. 			
✓ Provides death with dignity educational materials			
 Hospital pharmacies are permitted to dispense prescriptions in accordance with the purposes of the DWD Act.
